#### 2. Minimum Eligibility Criteria

- a) The Applicant/Participant should be an individual/ a registered company/ legal entity/ society/FPO/FPC.
- b) The Applicant/Participant should have requisite licenses/ certificates/ registrations to perform trade/ marketing/ processing of Agri./MFP based products listed in Annexure I.

#### 2.1. Technical Eligibility

Applicant/Participantshould have prior work experience in general trade/marketing/export/FMCG or/and of any goods or commodities having registered office/warehouse/wholesale or retail network/online presence on e-commerce platforms,

Or

Start-up recognized by Department for Promotion of Industries and Internal Trade (DPIIT), Government of India, related to Herbal/ Food Processing/ Agriculture and are willing to start their business in Minor Forest Produce based products' trade/ processing/ marketing.

#### 2.2. Financial Eligibility

Average Annual Turnover of Rs. 1.0 crores.

Net worth certificate.

The Applicant/Participant's registered company/ legal entity/ society should have positive Net worth and shall furnish details of the same (As per the format Appendix C),

#### 4. Empanelment Process

- a) The Applicant/Participants who qualify as per the eligibility criteria will be invited for further meeting.
- b) The agenda for the meeting will be to understand wholesale, retail network of the buyer or their existing capacity to procure and market the product/s.
- c) An Applicant/Participant can be empanelled for one or more Agri./MFP based products (as per Annexure I).
- d) Listing of products will be done (Tentative list as per Annexure I) & empanelment for each Agri./MFP based product will be done separately.
- e) All the empanelled bulk buyers are eligible to purchase Agri./MFP from SIDHKOFED.
- f) During procurement season, buyer has to give purchase intention mentioning quantity, rate, location and deposit prescribed EMD (refer point no. 8(a)) in the escrow account.
- g) Based on the purchase order, SIDHKOFED will decide and confirm online about price, quantity and location via mobile app-based trading platform.

#### 5. Period of Empanelment

The Applicant/Participant shall be empanelled for a period of 1 (One) year which could be extendable by another 1 (one) year considering past performance, fulfilment of obligations (legal) and the terms & conditions mutually agreed up on between the Authority & Applicant/Participant.

The Authority reserves the right to issue a fresh notification anytime including validity duration of this EoI, to invite additional agencies for empanelment. The decision of Authority shall be final and binding to all the Applicant/Participants submitting their proposal for this EoI.

#### 6. Quantity of sale

- a) There will be online portal through which empanelled buyers has to match sale price floated by the SIDHKOFED on NeML portal. Buyer may also give their purchase price on the portal.
- b) Authority shall undertake to provide the mentioned quantity as per the availability of Agri./MFP products.
- c) In case of multiple Applicant/Participants for Agri./MFP based products and with limited availability with Authority, the decision shall be taken considering the price, quantity, priority. Authority reserves the right to take a final decision for quantity of sale.
- d) The Authority's decision shall be final and binding to all the Applicant/Participant while deciding the final quantity of sale.
- e) Tentative list of Agri./MFP based products is updated on daily basis on NeML portal subjected to change as per market demands.
- f) The Authority provides the following options to the Buyer:
  - i. For Bulk Packaging: The Buyer has to arrange for bulk containers for lifting the products from the delivery centres.
  - ii. For Retail Packaging: The Buyer who are interested in retail packaging of products has to incur additional cost of providing retail packaging material and labour expenses.

#### 7. Procurement Price

- a) The Authority reserves the right to determine the price of finished product/s for sale. The price of Agri./MFP based products shall be revised every year by the Authority.
- b) SIDHKOFED will update the sale price of Agri./MFP on periodic basison NeML portal. (Tentative sale price is subject to change at the Federations' discretion.
- c) The Applicant/Participant has to make arrangement for lifting of Agri./MFP products from different units of authority at their own cost. Authority shall not provide any transport/cost associated with transportation of the finished products.
- d) All the taxes and statutory charges shall be additional and as applicable.

- 8. Trade Terms & Conditions and Applicable Fees
  - a) On every purchase confirmation, buyer has to deposit EMD at prescribed percentage
    - For purchase via Krishived app- 2%,
    - For purchase via Prior Rate Contract 10% (clause of 30 days stock holding will be there) or 20% (clause of 45 days stock holding will be there). After that, the said EMD may be forfeited. If party submits valid reason for delayed lifting, bank interest on trade value will be chargeable from the party.
    - For purchase via e-auction / tender 05% of the order value.
  - b) A Registration charges of Rs. 5000/- and 18% GST i.e., Rs. 5900 shall be remitted toNCDEX e-Markets Limited(NeML) by way of electronic fund transfer in any of the followingNCDEX e Markets Limited Accounts for participation.

- c) Apart from EMD & Registration fees, there are 2 otherfees which will be borne/payable by registered users (other thanGovernment/ Government undertaking agencies/Cooperative societies registered under Cooperative Society Act & getting financial support from Government etc.):
  - i. For Disposal of Commodities through e -auction, procurement through reverse auction -Such percent of the value of commodities disposed-off through the Electronic Platform, not exceeding 0.5% plus GST of the traded value.
  - ii. Demand Aggregation, price matching and settlement using Krishived 0.5% plus GST on the traded value.
- d) The EMD will be released after completion of purchase order and the same shall be used for next purchase order confirmation.
- e) Violation of any Clause(s) of the agreement shall be deemed as violation of Terms and Conditions of EoI. This would result in forfeiture of EMD. Further Buyer may be barred from participating in

subsequent empanelment proceedings. Such suspension will be initiated without assigning any reason whatsoever.

#### 9. Process of Sale

- a) The release of the Agri./MFP based product will be done after completion of fullpayment.
- b) The empanelled Buyers will be communicated via online portal and email about the location of warehouse/ delivery center, details of the product, contact details of the authorized person at the delivery center of the Agri./MFP based product.
- c) The Buyers shall compulsorily provide details of authorized person (Name, ID card number, contact etc.) who would be taking the delivery on behalf of the empanelled Buyer.
- d) Federation will certify the quality of the finished products on standard quality parameters (Organic/FSSAI/Ayush etc., whichever is applicable) along with shelf life of the product/s before the product is moved out from the warehouse/production unit.
- e) In case multiple buyers are interested for the procurement of the same Agri./MFP based product, the capacity of buyer to procure the Agri./MFP based product from the Federation will be decided based onthe first come first serve basis and/or the best price quotationThe federation will decide the quantity of the product which will be sold to the empanelled buyers.
- f) Apart from the EMD Deposit, the buyer has to make full payment to the Seller for the requested order before taking the delivery of the product.
- g) Once the final product has been lifted from the Warehouse/storage facility/production unit it will be sole responsibility of the buyer to ensure proper storage and handling of the products and federation will not be responsible for any deterioration in the product quality once the product moves out of the Warehouse/production unit.

#### 10. Delivery of Products

a) The buyer shall make the full payment for the requested order by the way of electronic funds transfer to the Federation's bank accountfor taking the delivery of the product from the delivery center.

- b) It is liability of the empanelled buyer to pay any taxes including GST if any payable. Buyer shall pay, cost of packaging (if any applicable), transportation charges, transit insurance, and loading charges and other incidental expenses incurred for taking delivery at respective delivery center.
- c) The buyer will provide containers for taking delivery of the Agri./MFPbased products and the same will be delivered unpacked in the given containers after proper weighing of the finished products. Delivery note will be given to Buyer with the details of the product mentioning certification status and shelf life of the product.
- d) Any loss of finished products occurring during the transportation /in transit shall be solely buyer's responsibility.

#### 11. Legal Obligations of the Parties

- a) CEO, SIDHKOFED decision will be final in case of any violation of trade practices, mis-appropriations, mis-information's etc.
- b) In no event will Seller's liability exceed the total amount paid by Buyer to Seller for the total of all the shipments for any cause of action or future claim.
- c) Buyer will acknowledge and agree that Seller is not liable for any special, indirect, consequential, or punitive damages, including but not limited to lost profits and/ or loss of business, arising out of or relating to the agreement in any way.
- d) The seller will not be responsible for any delay in providing the finished products to the buyer due to any unforeseen reasons for which the seller will notify the buyer within 15 days prior to the date of delivery.
- e) The finished products can be sold with different brands as preferred by the buyer and the seller will not be responsible for any legal claims afterwards i.e.,once the final product moves out of the Warehouse/storage facility/ production units, the federation will not be liable for any claims related to legal, quality parameters of the product.
- f) Federation shall not be liable for any claims, disputes for the products once they are picked up by the buyer from the production facility.

- g) Any license related to packaging, branding, storage, export, and any other certification will be sole responsibility of the buyer.
- h) Federation will not be responsible for any license or certificate of the finished good once it gets dispatched from the Warehouse/storage facility/production unit.
